NMIOTC Commandant's Editorial

It is of undeniable common understanding that the Peace and Prosperity of humankind passes through the Seas. And the maintenance of open and secure vital sea lanes is a task that NATO, -dedicated by default to the preservation of peace and stability- could certainly not omit.

The necessity to enhance our capabilities in Maritime Security Operations emerged in the aftermath of 9/11 and the following turbulence. The Hellenic Republic was keen to undertake this mission and along with the friend and allied Nations of Turkey, Bulgaria, Romania, Italy and the Check Republic established NMIOTC. Poland and Germany later joined in as Sponsoring and US and the UK as Contributing Nations respectively. NMIOTC is the only NATO Education and Training Facility dedicated to

the maritime domain, and one of the very few capacity-building institutions for Maritime Operations worldwide. Maritime Interdiction Operations have proven to be the key enabler and a solution provider in all aspects of maritime security operations, as acknowledged by NATO.

In the Alliance we like abbreviations and acronyms a lot. Interdiction Operations accomplish the mission using the three D's (delay, disrupt, destroy) and implement the three I's (interoperability, interconnectivity, integration) as required in all modern day operations, in the pursuit of Projecting Stability. As for NMIOTC, well it certainly has the three L's. Location – location - location! This shipdesigned like building, stands in an outmost strategic point in the Eastern Mediterranean in equal distances to all

major chock points, with Souda Bay being a safe haven for all naval Units to or from operations. The Center is situated in an enchanting natural environment, and it is surrounded by numerous supportive and interoperative military facilities such as NSA, NATO FORACS, NAMFI, Naval Base, etc.

But while all this beauty and convenience, the true reason of the Center's success throughout these 10 years, is the pursuit of excellence in the education and training provided, being focused in efficiently addressing to current and upcoming menaces for Maritime Security. To achieve that, we constantly keep an open eye to the most modern Asymmetric and Hybrid threats, and -equally important- we always seek to establish functioning networks of cooperation and knowledge-exchange with all the major

stake-holders in the game.

Having started modestly 10 years ago with only 5 courses, mainly focusing in Maritime Interdiction Operations basics and Countering Piracy, we have eagerly expanded in developing and delivering twenty two Resident Courses and a big series of customized trainings, responding to a wide spectrum of areas/threats, including: Cyber Security, C-IED, Countering Proliferation of WMD (+CBRN weapons), Counter Illicit Trafficking (both human and goods), Protection of Critical Energy Infrastructure Offshore, Biometrics and Evidence Collection, etc.

Yet, we live in a rapidly changing world and the form of potential threats is ever-changing as a chameleon. While some years ago it was Piracy in the Indian Ocean, today we are dealing with even more difficult and perplexed challenges. Our contribution here, in NMIOTC, to cope with all such current and emerging challenges, consists not only of capacity building through the extensive and always updated training of NATO and Partners personnel (Navies, SOF, Coast Guards, etc), but also through innovation, experimentation and doctrine simulation, as well as through exchange of expertise on all aspects of Maritime Operations.

Considering Socrates' lecture that the admission of ignorance is the beginning of wisdom, we have acknowledged our demand for expertise-outsourcing and we have paid great attention in developing synergies with those who know best in every matter. To this end we have established a network of cooperation with prominent or-

ganizations and institutions to include several Universities and Research Institutions promoting expertise and innovation in differentiated fields of knowledge.

Above all, we seek the collaboration of the actual protagonists of the Seas. Naval and Law Enforcement Operators, mariners and the people of the shipping industry, they are in the epicenter of our concerns, and what keeps them awake at nights becomes the big Q that leads our efforts to always adjust and improve our services to their benefit, while developing NMIOTC and Souda Bay as a regional hub for Maritime Security and Operations.

The training provided at NMIOTC is thus always practically oriented, following the principal "train as you fight and fight as you have been trained" and simulates real life -day and night- situations, using assets and means of actual maritime operations, but without making any discounts in safety and in security procedures.

Overall, the training and education provided by NMIOTC has been appreciated by our trainees, more than 7.000 throughout these 10 years, but also by our Chain of Command in NATO. NMIOTC was the first NETF ever to be awarded by the Allied Command Transformation with a Quality Assurance Unconditional Accreditation, being a proof and a moral satisfaction that "we do the right things, but (also) we do the things right".

Visions without resources are illusions they say, thus it is worth mentioning at this point, that NMIOTC is an organization that runs largely on its own resources. In times of auster-

ity and economic turmoil, we set the goal and achieved a crucial degree of financial sustainability, allowing us to develop without restrictions and with no further burdening our Nation's budgets.

It is self evident that these developments and achievements are not the work of one man or of a single nation. In the face of the NMIOTC Former Commandants, we pay tribute to all those people from all participating nations, who have worked passionately these 10 years and have delivered all these tangible effects. But maybe, above all, the real success of this Center is the family bonding and friendship among us, the crew of the ship, and the everyday joy we experience at work, doing our job efficiently. The real force multiplier of our efforts are the flags flying on the poles outside the building, the osmosis and cooperation of officers from 10 nations, working side by side and bonding to the common benefit.

An iconic figure of the shipping history of the 20th century, Aristotle Onassis, used to say: "We must free ourselves of the hope that the sea will ever rest. We must learn to adjust our sails in high winds." Keeping this thought as a guide, as we celebrate the NMIOTC 10th Anniversary, we promise that we commit ourselves in maintaining this thriving momentum, and keep operating NMIOTC as a quality provider of maritime capacity building, as a Mediterranean hub of synergy and cooperation and as a promoter of knowledge and expertise in maritime security, ever adjusting our sails for the common effort of Peace and Security at Seas.

I am Admiral Manfred Nielson the Deputy Allied Commander Transformation. I serve in NATO's home in North America - Norfolk, Virginia.

It is a truly great honor for me to be here with you to celebrate the 10th anniversary of the NATO Maritime Interdiction Operations Training Center (NMIOTC), and I want to start by wishing you all, on behalf of the United States, a very sincere $X\rho \acute{o} via \Pi o \lambda \acute{o} \acute{o}$. I know Capt. Tewell also just celebrated the U.S. Navy's 243rd anniversary, so let me also say happy birthday as to an amazing group of American sailors who keep us safe and advance U.S. interests in this strategically important region.


During his visit to Athens last May, Admiral Jamie Foggo recognized NMIOTC as a center of excellence where people from all over the world come together to train and to improve maritime security. During his visit, there were Greek, Turkish, American, and other partner nation sailors training here at NMIOTC. The center was also hosting the closing ceremonies for a major multinational exercise, Phoenix Express. This facility is a true gem of our NATO partnership, and we are grateful to the Hellenic Armed Forces for hosting it.

NMIOTC supports Greece, our EU and NATO allies and partner nations, through training on defense, security, law enforcement, and counterterrorism.

Over the years, NMIOTC has also helped to build bridges with many nations that are not members of the NATO alliance, including trainees from the Partnership for Peace, Mediterranean Dialogue, and the Istanbul Cooperation Initiative — from countries like Cyprus, Ukraine and Georgia, which share Greece's strong maritime traditions and look at Greece as a natural partner. NMIOTC has also provided an

international forum to discuss issues related to maritime security threats, such as transnational organized crime at sea, and to develop solutions to global security challenges.

NMIOTC is also helping to address the many challenges that Greece faces uniquely because of its geographic location at the meeting points of continents. In this regard, NMIOTC advances the Ameri-



can strategy of engaging Greece as a pillar of regional stability. As I have often said, Greece sits at the nexus of three strategic problem sets. From the east, there is the ongoing Syrian conflict, the threat of Iran, and asymmetric threats from the eastern Mediterranean. To the south, we see ongoing instability, arrival of refugees and other problems emerging from a yet-to-be united Libya, and to the north, Russia continues to threaten our collective security through its illegal annexation of Crimea, militarization of the Black Sea, and malign influence across the western Balkans.

Greece is a key U.S. ally in dealing with all three of these regions. Through its creation of new partnerships, such as trilateral dialogues with Cyprus and Egypt and with Cyprus and Israel, Greece is taking a leadership role that will pay dividends by stabilizing the area, increasing security, and boosting opportunities for economic growth.

Last week, in his public statements before meeting Greek Minister of Defense Panos Kammenos, our Secretary of Defense James Mattis, whom I was proud to see here at NMIOTC in one of the videos, recognized Greece's vital role in maintaining regional security. He expressed our appreciation for Greece's leadership in promoting Balkan stability, citing the Prespes Agreement as an example, and commended Greece's strong investments in its defense capabilities. And, of course, he singled out NSA Souda Bay as the flagship of our defense and security cooperation.

This most recent meeting of our two Ministers of Defense and the honors attended to Minister Kammenos were an important milestone in deepening our bilateral defense relationship, recommitting to our NATO alliance, and shaping our defense and security agenda, as we build on the success of the Thessaloniki International Fair and look ahead to the first U.S.-Greece Strategic Dialogue in December.

So, I am here today to reaffirm what has been a top priority for me since I started as U.S. Ambassador to the Hellenic Republic.

First of all, we are grateful for the depth and strength of our military partnership with Greece, for Greece's continued hosting of Naval Support Activity Souda Bay, its strong commitment to NATO and its fulfillment of its obligations on defense spending, and we are sensitive to the complicated neighborhood where Greece must operate. And, with this in mind, our Embassy team is focused on working with our partners in the Greek government to find opportunities to take this relationship forward and to



identify new and expanded avenues for cooperation.

Last year, for example, Greece contributed tremendously to the success of Atlantic Resolve by enabling a substantial portion of the U.S. Army's 10th Combat Aviation Brigade to enter the European theater through the port of Thessa-

Ioniki and to depart through Alexandropoulis.

This year, the helicopter movement will be centered at Stefanovikio and will involve more aircraft and solders than ever before. This level of cooperation benefits both our countries by improving NATO transit capability, developing flexible alternatives, and providing another expression of our close security cooperation.

Earlier this year, we resumed Alexander the Great, a large-scale joint exercise between our nations' Marines, and we've also begun a temporary deployment of U.S. UAVs at the Hellenic Air Force base in Larissa. So, this is truly a joint effort, involving all our services and the full spectrum of capabilities, a point that I know General Dunford has emphasized in his recent engagements with Admiral Apostolakis.

And the U.S. has also supported Greece's efforts to take on additional NATO missions and to exercise a leadership role in regional security. We are grateful for the fact that Greece, in 2018, increased its footprint in Afghanistan within the NATO-led Resolute Support mission. Thank you for your contingent of advisors to the Afghan Air Force at the Kabul Air Wing.

In June 2018, Greece also sent aircraft to participate in NATO's Air Policing mission over Slovenia and Albania. In Thessaloniki, Greece hosts a NATO Rapid Deployment Corps headquarters combined with its Third Army Corps, which started its tenure as NATO Joint-Command HQ for two years, highlighting northern Greece's strategic significance to the Alliance.

In this context, and here I'll wind up, the NMIOTC is especially important. It trains our militaries in the skills, interoperability and cooperation at sea that is essential among allied and partner-nations. It reflects Greece's strong naval capability and deeply rooted maritime traditions in a way that helps us to navigate challenges that our forces confront. Over the past decade, NMIOTC has grown, evolved, and become more important in response to evolving regional maritime security demands. The next decade will surely present new challenges, but I am confident that NMIOTC's curriculum and training will continue to develop and help prepare the next generation of maritime leaders and sailors. And I am confident that the United States and U.S. forces will remain very strong partners in this regard.

So, congratulations again, on all the good work that you've done these past 10 years, and I wish you 100 more.

in 2008, NMIOTC has done an outstanding job in providing advanced training services to NATO and our partners.





Background

After the dramatic increase of terrorist acts during the previous decade, new forms of threats have appeared, whereas the old ones have changed. These new forms are mainly cross-border threats like proliferation of weapons of mass destruction, illicit trafficking, etc. Therefore, collective efforts of the member-states have been required. In this attempt, security issues for the maritime environment, which are carried out through Maritime Interdiction Operations (MIO), have also been developed.

One of these was the Operation Active Endeavour (OAE) which was established in the Mediterranean Sea and was initiated in order to deter, defend,



disrupt and protect against terrorist activity.

It was a collective defence operation that, initially only involved NATO member countries until it started accepting non-NATO countries' participation in 2004.

OAE hailed merchant vessels and boarded suspect ships, intervened to rescue civilians on stricken oil rigs and sinking ships and, generally, helped to improve perceptions of security.

NATO ships also systematically carried out preparatory route surveys in "choke" points, as well as in important passages and harbors throughout the Mediterranean.

NATO, responding to these new operational needs and attempting to meet its requirements, had developed new training activities. With this background and in order to fulfill the related training gap the NATO decision to found NMIOTC was taken during the meeting of Defence Ministers of the member states of the Alliance on June 12th 2003.

As a result the Hellenic Navy General Staff created the NMIOTC Foundation Coordination



Office, in November 2005 with the aim to found the Centre and to obtain its definite operational capability.



The same month, the Memorandum of Understanding among the Ministry of National Defence of the Hellenic Republic and the NATO Structure Commands was signed in Brussels. The Memorandum of Understanding determined the Functional Relationship for NMIOTC successful operation as a multinational manned training centre for enhancing NATO's Maritime Interdiction Operations capabilities.

The mission of NMIOTC set by this Memorandum is to conduct the combined training, necessary for NATO forces in order to execute better surface, sub-surface, aerial surveillance and special operations activities supporting Maritime



Interdiction Operations.

On the 18th of December 2007 the MOU regarding the participation in NMIOTC manning, activities and provision of training was signed between the Hellenic Ministry of National Defense and the initial sponsoring Nations: Bulgaria, Czech Republic, Romania and Turkey.

On the 17th of March 2008 the Centre acquired Full Operational Capability. The Official inauguration took place on the 14th of October 2008 at Souda Base, Crete.



In the period leading up to these events, and later on, the Centre consolidated and improved internal organization and its education and training products, and at the same time was committed to make itself widely known.

During the previous decade the terrorist threat increased. Since 2008 the piracy phenomenon at sea was escalated as well.

From the total number of only 10 to 15 incidents in 2004, the waters of the Gulf of Aden saw acts of piracy increasing rapidly to 80 in 2008.



The consequences of the Somali Pirates became more dramatic, more expensive, and more risky to human life. The situation became so serious that the UN Security Council produced a series of resolutions in order to call maritime states to react properly.

UNSC Resolution 1816 in June 2008, authorizing nations to deploy warships for counter-piracy operations in Somali territorial waters.

This was followed by UNSC Resolution 1838, in October 2008, urging all maritime states to dispatch naval units to fight piracy, off the Horn of Africa (HOA).



NATO was very quick to react to the threat posed by piracy in the Gulf of Aden, with Operation Allied Provider, that commenced in October 2008 after the North Atlantic Council (NAC) agreed to the UN Secretary General's request for assistance.

The NATO task force - Standing NATO Maritime Group 2 (SNMG2) - provided close protection to the World Food Programme (WFP) chartered ships and conducted deterrence patrols in the area most susceptible to criminal acts against merchant shipping.

Then from March to August 2009, NATO ran

Operation Allied Protector, a counterpiracy operation, to improve the safety of commercial maritime routes and international navigation off the Horn of Africa. The need was still of high importance that on August 2009 the NAC approved the new Operation Ocean Shield (OOS) focused on at-sea counter-piracy operations off



the Horn of Africa.

It also offered, to regional states that requested it, assistance in developing their own capacity to combat piracy activities. Since the summer of 2008, individuals and units from NATO and Partner nations began to come for training at NMIOTC.

2009

Year by year, the rate of training activities at NMIOTC, grew. During the course of 2009 for example, 22 NATO units and 1 Ukrainian frigate



undertook training at the Center.

In 2009, NMIOTC also participated in the planning and the conduct of MIO related exercises with the involvement of surface units and more than 200 multinational trainees from more than 10 NATO and non-NATO nations.

The same year, the Centre conducted individual



training courses related to Boarding procedure concerning both Command Teams and Boarding Teams. This training was delivered through the courses 1000, (Command Team – Theoretical training), 2000 (BT theoretical issues), 3000 (BT practical issues) and 4000 (Naval Unit Final Training Tactical Exercise – FTX), as well as the pilot Course for Maritime Operational Terminology. During the first year of activity NMIOTC also provided certain education to the Standing NATO Maritime Groups, SNMG1 and SNMG2, prior to their deployment in Operation Ocean Shield.

NMIOTC, in the same year, participated with its means and personnel in an experiment, conducted by the United States Naval Post-Graduate School Monterey (NPS), regarding communications architecture for provision of real-time reach back support to the Boarding Team, from ashore, during a suspect ship search.



In October NMIOTC conducted a high level seminar on Maritime Interdiction of Weapon of Mass Destruction. The seminar was the first commitment to support the NATO community in promoting and organizing forums for discussions and sharing of knowledge and experience in the

area of Maritime Interdiction Operation related issues.



2010

In 2010, following the previous year seminar on the matter, the new course on Weapon of Mass Destruction in MIO was started.

In the same year the initial team of NMIOTC



Sponsoring Nations was further enriched with the joining of Italy and the assignment of the first Italian officer on September 2010 was fact.

In the following years the training activities have been increased rapidly. The quality and the number of courses have been growing continuously during the first decade of NMIOTC activities. The Centre has been developing a wide spectrum of courses related to MIO.

2011

In 2011 the Centre provided the first resident course on counter piracy upon request of the ship stopped in Souda on her way to the area of operation in the Horn of Africa.

2012

In 2012 the Maritime Chemical, Biological,



Radiological Nuclear (CBRN) detection. identification and control operation field trial was conducted.

2013

In 2013 the Counter-Improvised Explosive Device (C-IED) considerations in Maritime Force

In November of the same year the center was awarded the QA unconditional accreditation by ACT and was the first NETF that obtained this certification.

2014

In 2014, the course on legal issues in MIO was initiated.



2015

In 2015 both the UK and the US decided to contribute to the NMIOTC efforts, by assigning maritime operations expert officers to the Center, starting from January and July respectively, on a rotational basis.

2016

In 2016, NMIOTC developed the new courses on Autonomous Vessel Protection Detachment, the C-IED considerations in MIO, the MIO in support of international efforts to counter human trafficking activities at sea for Command Team, the Maritime IED disposal, Maritime biometric collection. We also started the Train the Trainers and a module



on "Gender Perspective in Maritime Operations".

2017

In 2017 the course MIO on support of international efforts to counter migrant smuggling activities at sea - practical issues, Maritime Aspects of Joint Operations and Cyber Security awareness

in Maritime environment were introduced in the Centre.

2018

In 2018 we started the first trial of the course Protection of Critical Maritime Infrastructure, and developed the Medical Combat Care in Maritime Operations and the Managing Insecurities in the Maritime Environment.





In March NMIOTC Sponsoring Nations community was further enriched with the joining of Poland by the assignment of the first Polish officer. Now we are in the final stage of the procedure for Germany to join the centre.

In October 2018 NMIOTC has fulfilled 10 years of training presence and the achievement of recognition inside NATO Structure is apparent.



Future

NMIOTC relying on its 10-year experience will continue to accomplish its mission, to conduct the combined training necessary for NATO and partner nations to support Maritime Interdiction Operations.

As we in NATO are well aware, the Maritime environment is vital for the global community. Oceans connect nations globally through an independent network of financial, social and political relationships.

With this always in mind, we are trying to depict some aspects of the new security environment by providing a dilating approach in the major threats especially occurring in the maritime environment, such as Piracy, Illicit Trafficking of Weapons of Mass Destruction, CBRN, Maritime Improvise Explosive Devices, taking into account all our experience and accumulated knowledge in the field.

All these threats are still countered through the four agreed pillars of the Alliance Maritime Strategy: Deterrence & Collective Defence, Crisis Management, Cooperative Security and Maritime Security.

And all the related operational tasks are linked to the new concept of asymmetric threats. All these tasks are strictly connected to the related training needs of the Navies to which the NMIOTC is fully committed.


