This is Change 13 of the NMIOTC Directive 60-1 and defines training fees for the F.Y. 2025-26 (Change 13 entirely supersedes reference D).

1. **Applicability.** This directive is applicable to all organizations, agencies, commands and units participating in NMIOTC's training. It should be used as a guidance for the calculation of the cost of NATO Maritime Interdiction Operational Training Centre (NMIOTC) training.
2. **Interim changes.** Interim changes are authorized when approved by the NMIOTC Commandant.
3. **Purpose.** To define fees for training provided by NMIOTC, respective methods of payment and procedures for F.Y. 2025-26.
4. **Overview.**
 - a. NMIOTC is funded and logistically supported by the Hellenic Republic IAW ref. C.
 - b. Based on the above concept, NMIOTC will prepare and provide access to costs of training via its official webpage annually. These updated tuition fees will apply until 31st December 2026. The tuition fees for the F.Y. 2025-26 are presented in Annex A. From the division and individual pricing of the modules as they appear in the Appendices of Annex A Courses 17000, 19000, 24000, 25000 and 27000 have not been included as they cannot be separated into individual modules.

c. Tuition Fees for resident courses include transportation during the training days from specific pick-up points of the city of Chania to NMIOTC's premises and vice versa. Trainees or their sending authorities are responsible to cover travel and lodging expenses.

d. NMIOTC's Budget & Finance Department and the OPRs are responsible for following the appropriate procedures and providing relevant clarifications to trainees or their authorities.

5. **Payment procedure.**

a. During the in-processing stage of a NMIOTC training program and prior to the related final allocation, a "Financial Agreement" (Annex B) may be signed either by the trainee himself or, in case that the training is provided collectively to a ship/group, by the official authority of the group/ship/organization. The signed document has to be submitted to the OPR of the specific activity prior to the final allocation of the scheduled training.

c. Payment for Tailored Trainings: Upon completion of each training, an invoice will be issued and signed (Annex C). The invoice will include the final total cost that has been charged according to the specific training provided by NMIOTC. Copies of the aforementioned document(s) will be provided to the financial representative of each group/ship/organization who will be responsible to forward the document(s) to the appropriate authority (MoD, General Staff, agent etc.) as well as to provide the POC details (eg name, email) of the payment authority (authority which is going to initiate the payment procedure or/and to perform the payment/deposit). The respective payment/deposit must be executed within 60 days from the date of issue of the above document(s) to NMIOTC's bank account mentioned on the invoice. Upon completion of the payment procedure, the payment authority must return to NMIOTC (papadakisst@nmiotc.nato.int , lafkasm@nmiotc.nato.int , michaleasi@nmiotc.nato.int , larentzakism@nmiotc.nato.int , kouroupia@nmiotc.nato.int) the appropriate bank deposit receipt.

6. Cancellation of participation - Obligations.

a. NMIOTC courses are in high demand, therefore a late cancellation of a confirmed course significantly impacts NMIOTC's ability to maximize training opportunities for the Alliance and results in a financial loss for NMIOTC. Upon receipt of written confirmation from NMIOTC that your course has been placed on the NMIOTC calendar, our cancellation fees apply as follows:

Cancelation between 30 to 15 days from course start date:	10% of student tuition due
Cancelation between 14 to 8 days from course start date:	25% of student tuition due
Cancelation inside of 1 week from course start date:	50% of student tuition due

b. Regarding tailored trainings and METT (Mobile Education and Training Team), in the event of cancellation, the entity which scheduled the training remains financially obligated to NMIOTC for any irrecoverable costs related to the cancelled training (e.g Augmenter's SMEs expenses, advance lease transport etc.).

c. If the NMIOTC Student Admin Affairs Section (SAA) receives a cancellation of training allocation, it will inform the requesting Authority by fax or e-mail about any related financial obligations, adducing relevant documents of irrecoverable expenses concerning the preparation of the cancelled training.

7. **Mobile Education & Training Team (METT).** NMIOTC can provide training via Mobile Education & Training Teams (METT) upon request. In this case, tuition fees will be accompanied by the respective costs accordingly (e.g. costs associated with NMIOTC personnel accommodation, travel, and/or meals) and the training requestor or their representative will be informed about the final cost upon the issuance of NMIOTC's invoice.

8. A Team / Unit / Ship can create a tailored training package in accordance with its specific operational requirements, in close cooperation with NMIOTC staff. In this case, modules from different courses may be selected and the final cost of the "package" will be calculated by adding the respective costs of each selected module, the cost of consumables (e.g. simunition rounds, fuel consumption, employment of training assets, means of transportation, etc.) and any other associated costs.
